To give the possibility to all the stakeholders to express themselves, Delegations will be kindly invited to limit their interventions to 3 minutes.

4.2 Highlights from the ERA-related Groups

Updates by the ERA-related Groups, together with key points for discussion, will be provided in writing to Delegations prior to the meeting. Delegations will have the opportunity to ask questions in relation to the notes and key points provided.

5. ERA and Innovation Policy

5.1 Strategic debate: how to improve national Research and Innovation systems of Member States and Associated Countries

The Commission co-Chair will make a short introductory presentation on the European Semester and the Reform Delivery Tool, followed by the Member States co-Chair with an outline of the ERAC Annual Report 2017. Based on recent reports on R&I performance and policies and activities under the Policy Support Facility, Delegations will be invited to exchange views on how to further optimise the efficiency and effectiveness of their national Research and Innovation systems, with a focus on performance based funding of public research and R&D tax incentives. Background papers and lead questions will structure the exchange of views, which will limit the intervention time to 3 minutes per Delegation. The outcome of the debate may contribute to the planned Council conclusions on ERA.

5.2 ERAC Ad-hoc Working Group on Partnerships and follow-up

The ERAC Ad-hoc Working Group on Partnerships will present its final reports on "Rationalising the partnership landscape" and "Increasing the efficiency of implementation of partnerships" for debate and in view of their adoption at the meeting or shortly afterwards.
