# Draft R&I Programme Priorities

- Political impact of the Recovery and Resilience Fund (RFF) at the European level on R&I system, but also on the sectorial policies: building the European Research Area and creating resilience towards future crisis.
- Achievements of the New Innovation Agenda and the Innovation Ecosystems, with a specific focus on territorial and local cohesion impacts.
- Highlighting the benefits of Science for Policy. Discussing the role and contribution of R&I advisory bodies to the design and development of sectoral policies.
- Drafting Political Orientations towards the Horizon Europe 2<sup>nd</sup> Strategic Plan (2025-2027)
- *Pending on decision of the COM. Launching PRIMA-2: Extending PRIMA under art 185. An essential partnership for the EU collaboration on R&I with the MED countries with a broader agenda. MED solutions for Europe.*


# Draft R&I Programme: Legislative Initiatives

- (*Foreseen*) A possible Commission legislative initiative: Amendment to Decision 2017/1324: a new PRIMA established under article 185 of the Lisbon Treaty with a broader Strategic Research and Innovation Agenda (SRIA) and Horizon Europe funding in the current Multiannual Framework Programme.
- (*Currently running and not expected but keeping an eye*) Amendment of the Basic Single Act for the inclusion of Chips-JU

# Draft R&I Programme: Non-Legislative Initiatives

- Council Conclusions:
  - *Impact of Science and Innovation in transforming policy making:*
    1. Impact at European level of the RRF funds over R&I policies and R&I development of the ERA; R&I as a driver of changes and transformation of sectorial policies.
    2. Results achieved by the European Innovation Ecosystem, including the specific impact on territorial and local cohesion.
    3. Science for policy: advisory bodies and their contribution to the design and development of sectorial policies
  - *Political orientation towards the Horizon Europe 2nd Strategic Plan (2025-2027)*
